- 4. Africar Limited reserves the right to display & advertise the vehicle/s on the dealership website (www.Stallionafricar.com)
- 5. Storage charges as per below chart will be applicable if the customer wishes to withdraw the vehicle/s.
- 6. The customer will be charged as per below mentioned rates for the display of his vehicle at Africar showroom, website or both.
  - N 1,000.00 per day per vehicle (including weekends and holidays)
- 7. Africar Limited will not be held responsible for wear & tear and faults that may develop on the vehicle/s during the storage/display period.
- 8. In an event where the car is sold by Africar Limited, the dealership will charge 15% on the total invoice value per transaction.
- 9. Africar Limited will thereafter remit the sale amount minus the 15% to the Customer within 10 working days after delivery of the vehicle to the new customer.
- 10. Customer shall not engage in a parallel contract/ agreement directly or indirectly with any employee of Africar Limited.
- 11. Africar Limited does not undertake to or gives ANY of the warranties or guarantees under the Sale of Good Act of Nigeria or any other enactment for the time being in force in Nigeria to any purchaser of the vehicle/s except those given or to be given by the Customer.
- 12. Africar Limited shall be held blameless for any latent defect in the vehicle so displayed or sold by any purchaser and in the event of any legal action against Africar Limited; the Customer shall indemnify Africar Limited for all reasonable attorney fees (including out of pocket expenses in defending the action)
- 13. In the event of any dispute arising out of this agreement, parties shall resort in the first instance to arbitration to be presided over by a single arbitrator with Lagos High Court as the seat of the arbitration whilst the laws of Nigeria shall be the choice of Law (without its conflict rules)
